## 6 Accidental release measures

### Personal precautions, protective equipment and emergency procedures

### Methods and material for containment and cleaning up

## 7 Handling and storage

### Precautions for safe handling

**Protective measures** : Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapour or mist. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. Store and use away from heat, sparks, open flame or any other ignition source. Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use only non-sparking tools. ## 8 Exposure controls/personal protection

- Appropriate engineering controls** : Use only with adequate ventilation.
